PUBLIC HEARING – FY 2020 HIGHLAND COUNTY BUDGET AMENDMENT

Chairman Blanchard opened the Public Hearing and asked Ms. Lambert to provide a staff report.

Ms. Lambert advised, "The purpose of tonight's public hearing is to consider proposed amendments to the Highland County Budget for FY 2020 which will end on

June 30. The amendments will adjust the initial budgeted amount to actual revenues and expenditures.

REVENUES:

The Treasurer has revised several categories based on actual revenue collections.

EXPENDITURES:

Two (2) expenditure categories within the county budget need adjustment:

- 1. The Children Services Act Fund has been decreased to reflect actual expenditures. This fund is used for foster care, residential placements and associated costs.
- 2. The Capital Improvement Fund has been decreased to reflect actual expenditures.

When the original budget was adopted in May 2019, it was anticipated that a general fund transfer of \$292,997 might be needed at the end of the fiscal year to balance the budget if all funding was spent in each category. Actual expenditures will require a transfer of \$82,456 to balance the budget."
